2014 Property Tax Rates in Dallas County School Equalization

This notice concerns 2014 property tax rates for Dallas County School Equalization. It presents information about three tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. This year's effective tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's rollback tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.

x 1.08 = this year's maximum operating rate	\$0.010260/\$100

Statement of Increase/Decrease

If Dallas County School Equalization adopts a 2014 tax rate equal to the effective tax rate of \$0.009500 per \$100 of value, taxes would increase compared to 2013 taxes by \$203,336.
